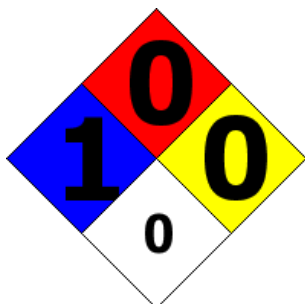

#### SECTION 4 : First aid measures

### Precautions for safe handling:
